



## **Terms and Conditions of Use for Hire of School Premises and Facilities**

### **Special Terms and Conditions for Use of 3G Pitch**

#### **1. Part 3G Pitch Code of Conduct**

In the interests of the pupils of Ravens Wood School and all other users, all organisations using the 3G pitch facilities are required to follow the rules of use listed below.

- All users must adhere to the pitch usage rules displayed on the entrance gate of the pitch (see Appendix A).
- All users must conduct themselves in a respectful manner, particularly in consideration of neighbours, in regard to excessive noise, bad language, and general inappropriate behaviour.
- All pitch and floodlight usage times must be strictly adhered to. In the interests of all pitch users, all hirers must stick to their hire times.
- Access to the pitch is strictly controlled via the main Oakley Road gates and then round the outside of the PE changing rooms. Access to other parts of the School or the grounds is strictly forbidden without prior permission.
- Organisers are responsible for the conduct of the players and other associated visitors (i.e. parents / carers). For security purposes, spectator numbers should be limited, and the presence of unknown persons should be reported to the School Site Team or 3G Booking Supervisor immediately.
- The pitch is only available for training purposes. No competitive matches, other than those associated with Ravens Wood School fixtures or activities, are permitted.

#### **2. Part Two: Use of Goals**

The hire of facilities **does not** include the use of equipment, including goals. However, in some circumstances and with **prior agreement** the use of goals may be permitted, provided they are available at the time. Use of goals is under the following conditions:

- Goals are to be used in accordance with normal procedures for use and manufacturers' guidelines.
- Any safety equipment associated with its' use must be used (i.e. goal weights / fixing points).
- Goals are to be returned to the location they were found in and secured according to how they were found.
- Any inappropriate use or damage sustained to the goals may result in those clubs being banned from their further use. The Hirer will be liable for any costs associated with the repair of goals as a result of misuse.
- Any fault or damage to equipment must be reported to the School as soon as it is found.
- Under **no** circumstances must the Rugby posts, if on the pitch at the time of hire, be removed / moved.

**Failure to comply with any of the rules may result in immediate removal from the pitch and a ban on future bookings.**

##### **Pitch Rules:**

- Do use clean footwear
- Do put litter in the bins provided
- Do use dimpled or rubber footwear
- No smoking or vaping
- No food or drinks (except water)
- No sharp or heavy objects on the surface
- No metal studs or flat soled shoes
- No swinging on goal posts
